### **PUBLIC PARTICIPATION IN BOARD MEETINGS**

3. Statements by members of the public should be concise and will be limited to 3 minutes.
4. A group of visitors with a common purpose will designate a spokesperson to speak for the group.
5. A visitor may be recognized by the chair by rising, identifying himself/herself with his/her full name and address, and stating his/her purpose for appearing.
6. Discussion or presentation concerning a published agenda item is limited to its designated place on the agenda.
7. Speakers may offer objective criticism of district operations and programs but the Board will not hear complaints concerning specific district personnel. The chair will direct the visitor to the appropriate means for Board consideration and disposition of legitimate complaints involving individuals.
